



## **Making DREAMs Come True: A Workbook to Help DREAMers Thrive in College**

The Making DREAMs Come True: A Workbook to Help DREAMers Thrive in College (the “Work”) License Agreement (the “Agreement”) is made between Washington State University (“WSU”), a public institution of higher education and an agency of the State of Washington and Licensee.

#### **BACKGROUND**

WSU researchers have developed a self-help workbook, Making DREAMs Come True: A Workbook to Help DREAMers Thrive in College to help undocumented students gain psychological resilience in facing their unique challenges. This workbook is based on years of research by Dr. Paul Kwon and his team, and has been tested and validated at WSU. Filled with anecdotes and hands-on exercises, the workbook provides guidance in increasing hope for the future, translating values into goals and action, overcoming obstacles, expanding one’s social network, overcoming negative thoughts about social interactions, becoming more emotionally wise, and dealing effectively with discrimination.

The Work is the intellectual property of WSU and is protected by U.S. Copyright Law and international treaties. The Work is licensed to individuals, institutions of higher education, or non-profit organizations, by WSU on the terms and conditions set forth below.

By checking the box marked “AGREE”, the Licensee acknowledges and agrees to be bound by the terms and conditions as set forth herein.

## **1 License Grant**

- 1.1 Provided that Licensee pays the license fee and conforms to the terms and conditions of the Agreement, WSU hereby grants, and Licensee accepts, a limited, non-transferable, non-exclusive license to access, display, use, and perform the Work.
- 1.2 Licensee shall not modify, distribute, publish, make derivatives based on the Work, or otherwise transfer or allow to be transferred the copies of the Work in whole or in part, without prior written permission of WSU. In no event shall the Licensee permit third parties or persons to use or display the Work.
- 1.3 Licensee shall gain no ownership in the Work and shall retain in the Work the copyright, trademark, or other notices pertaining to the Work as provided by WSU.
- 1.4 WSU reserves the right to modify or make improvements in the Works at any time without notice. WSU shall endeavor to update the Work as routinely as feasible.
- 1.5 Licensee agrees that nothing in this Agreement shall be deemed to create any form of professional relationship, including, without limitation, that of physician-patient or therapist-client, between WSU and the Licensee, and that the Licensee shall retain sole and exclusive responsibility and make all decisions for the care of itself or its clients or patients. In no event shall WSU, its employees, agents, or officers provide any services under this Agreement in the form of medical care, treatment or therapy to Licensee or Licensee's patients.

## **2 Fee, Delivery, and Format**

- 2.1 License fee for rights under this Agreement is USD \$15.99 ("Fee") and is due upon Licensee's execution of this agreement.
- 2.2 Upon execution of this Agreement and receipt of the Fee, WSU will send instructions on delivery of the Work to the email address provided by Licensee.
- 2.3 Licensee shall have access to the Work for so long the Work is protectable under the U.S. Copyright Act, 17 U.S.C. § 101 et seq. upon execution of this Agreement (the "Term").
- 2.4 During the Term of this Agreement, WSU shall endeavor to update versions of the Work. Under this Agreement, the entire scope and extent of the foregoing services shall not exceed the outline of activities in the Work.
- 2.5 Licensee hereby agrees that WSU may contact Licensee at mutually convenient times to request information on the deployment, efficacy, and enjoyment of the Work by the Licensee to assist WSU in further development of the Work.

## **3 Termination**

- 3.1 Licensee may terminate this Agreement at any time upon written notice to WSU.
- 3.2 WSU may terminate this Agreement if Licensee is in breach of any of its obligations set forth within this Agreement.

- 3.3 The provisions under which this Agreement may be terminated will be in addition to any and all other legal remedies which either Party may have for the enforcement of any and all terms hereof, and do not in any way limit any other legal remedy such Party may have.
- 3.4 Termination of this Agreement will terminate all rights and licenses granted to Licensee relating to the Work. Licensee's obligation to pay the Fee survives the termination of this Agreement.

#### **4 Warranties and Disclaimers**

- 4.1 The Work is intended only for use as a self-help aid and is not meant to be a substitute for professional care or judgment.
- 4.2 The Work is supplied "AS IS", without obligation by WSU to provide accompanying services or support. The entire risk as to the quality and performance of the Work is with the Licensee.
- 4.3 WSU EXPRESSLY DISCLAIMS ANY AND ALL WARRANTIES, WHETHER EXPRESS OR IMPLIED, PERTAINING TO THE MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT OF THE WORK OR ANY OTHER MATERIALS OTHERWISE PROVIDED TO LICENSEE UNDER THIS AGREEMENT.

#### **5 Indemnification and Liability**

- 5.1 Licensee shall indemnify and hold harmless WSU and its officers, faculty, employees, students and agents, against any and all claims, suits, losses, damages, costs, fees and expenses resulting from Licensee's use of the Work, including but not limited to, any damages, losses or liabilities whatsoever with respect to death or injury to any person and damage to any property. This indemnification clause shall survive the termination of this Agreement.
- 5.2 IN NO EVENT SHALL WSU BE LIABLE FOR (A) PERSONAL INJURY OR PROPERTY DAMAGES ARISING IN CONNECTION WITH THE ACTIVITIES CONTEMPLATED IN THIS AGREEMENT OR (B) LOST PROFITS, LOST BUSINESS OPPORTUNITY, INVENTORY LOSS, PROGRAM STOPPAGE, LOST DATA OR ANY OTHER RELIANCE OR EXPECTANCY, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, OF ANY KIND.

#### **6 General**

- 6.1 This Agreement does not grant permission to use the trade names, identifiers, trademarks, service marks, or product names of the WSU to the Licensee except as required for reasonable and customary use in describing the origin of the Work. All goodwill associated with the Work and WSU marks and identifiers shall inure to WSU. The Licensee shall not use the name "Washington State University," its logo, marks, or any abbreviation thereof to without prior written approval from WSU except as otherwise expressly provided in this Agreement.
- 6.2 This Agreement is made in and shall be governed by the laws of the State of Washington excluding choice of law principles. Any suit, action, or proceeding arising out of or relating to this Agreement shall be decided in Whitman County, Washington, United States of America.
- 6.3 Licensee accepts the venue and jurisdiction of the Federal District Court of Eastern Washington, Spokane, or the Whitman County Superior Courts.

- 6.4 This Agreement embodies the entire understanding of the Parties and supersedes all previous communications, representations, or understandings, either oral or written, between the Parties relating to the subject matter hereof. Any amendment of these terms and conditions must be in writing and signed by both Parties.
- 6.5 This Agreement and the rights and benefits conferred upon the parties hereunder may not be assigned or otherwise transferred by Licensee without the prior written consent of WSU.
